ISSUES TO REPORT	 Fencing and gates were seen in fair condition. The paddock fencing has recently had six new posts installed, resulting in a sturdier and more upright fence (Photo 1). Even so, the fencing is inadequate, a collection of posts, props, and rails, varying in length, type, age, and condition. Grass height is meeting the mowing specification. The prevailing soft ground conditions are clearly not ideal for mowing, and if commenced, might cause turf damage and soil compaction. Footpaths remain wet but not impassable. No obstructions were noted. Despite a grey weathered appearance, wooden benches within the orchard are in fair condition. All signs were in place and legible, including public footpath waymarkers. A skip will be delivered on the 31st of March. The skip is an ideal opportunity for tenants to raise housekeeping standards by disposing of redundant materials from plots and the allotment gardens. The Clerk has sent an email around to all plot holders letting them know about the skip and has also hand delivered letters to tenants who do not have email addresses. A plot in the top left-hand corner of the allotments is still not being satisfactorily maintained. Moreover, a makeshift fence is tipping towards FP6 and in windy conditions might easily topple over (Photo 2).
	8. The fruit trees are now receiving greater care and attention. Most trees are staked, and wood chip mulch is visible by each base, presumably to conserve moisture and thwart weed growth.

Please see previous reports about stacked soil. Playground signage is in place and legible. Graffiti has been removed from the bench at Aldbury children's playground. Positive feedback voiced from numerous parents about the suggested installation of a Wildwood Play Den considering it will suit the under-fives and meet imaginative play objectives.

ISSUES TO REPORT	
	 Grass height complies with the mowing specification requirements. An ongoing weekly litter pick continues to be undertaken, and from positive feedback, is welcomed. Older benches were seen in reasonable condition, if somewhat weathered. The new bench is being appreciated by residents and visitors alike. No visible defects detected on the mature trees; however, as noted in the previous report, small branches continue to be shed. Unsightly, soft verge damage caused by motor vehicle tyres is visible on the village green. Thames Water have been trying to locate a collapsed/damaged pipeline, running beneath the road by the PO and village green. The pipeline route has been marked out using aerosol paint (Photo 3). It is understood from an TW engineer that excavation works, particularly on the village green, would only be carried out as a last resort.

	 30. The following DBC work remains outstanding. Replace missing 'Stonycroft' street nameplate Ref No: 769147.
	 31. The following HCC Highway work remains outstanding. Faded markings by the Stonycroft junction (Ref No: 401002519044). Blocked drain opposite the church (Ref No: 401003062584). Manhole lifting during heavy rainfall near the Toms Hill/Stocks Road junction (Ref No: 401003153069). As previously reported, HCC Drainage team are
